SGA Committee Development: Moved by Vice President Brooks

Brooks: We should send out a web form to our senators so that they can read committee descriptions and sign up for their committees.

Alexander: wants to rewrite our election processes in our constitution with the help of VP Brooks.

Constitutional Revisions: Moved by Parliamentarian Alexander

Alexander: The first thing we want to do is hold a supreme court meeting so that our justices can look through our constitution and make necessary revisions. We would like to do it within the next week.

Senate Equipment: Moved by Vice President Brooks

Peebles: We are short about \$2,000 relative to last year and it doesn't seem necessary to purchase polos and name tags.

Alexander: We should revisit this before OSGA Spring Congress so that we look uniform when we attend.

SGA Online Communications: Moved by VP Brooks

Peebles: All executive board members have received invitations to add to our canvas but we should communicate with each other before we make changes to it. Ginger London needs a list of all current students so that they can be enrolled.

Alexander: There's a broad GPA requirement that rules all clubs and organizations.

Brooks: OSGA dues need to be written into legislation.

Peebles: outdoor amenities and sexual relationships are other areas of interest

Alexander: Other areas of interest include health services, notification requirements for schedule and professor changes, and feminine products should be available in restrooms on campus. We also need to think about BLM legislation. OU also passed legislation to cancel classes on election day to facilitate student voting.

Alexander: We could make a public web form for senators to input legislation ideas
